1. **FALSE** From the outside of the bus, check the operating condition of the dash mounted turn signal indicator lights, high beam indicator light, eight-light indicator system, instrument panel lights and step well lights. **CDL 10.1.2**
2. **TRUE** Proper adjustment and use of all mirrors is vital to the safe operation of the school bus in order to observe the danger zone around the bus and look for students, traffic and other objects in the area. **CDL SB 1.2**
3. **FALSE** School buses are allowed to stop in the intersection to load/unload students in order to control traffic in all directions. **SBM 5.6**
4. **TRUE** When parking, it is best practice to park so you can pull forward when leaving. **SBM 1.4**
